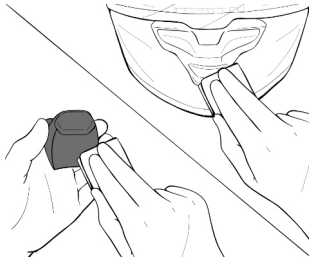
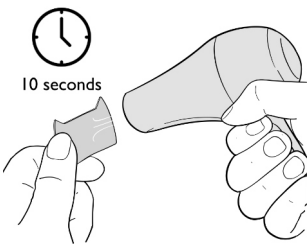
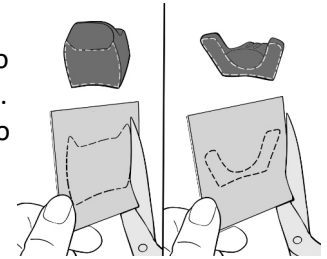


1. Before fitting, check the fit of the helmet and Quickclip. Make sure that everything fits properly. Brackets that have come into contact with the adhesive cannot be replaced. Use the product images on our website (www.mibike.de or eBay) to find the exact position for the bracket.



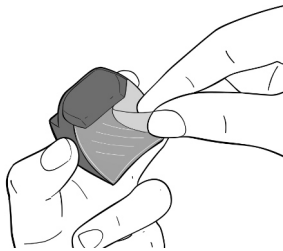
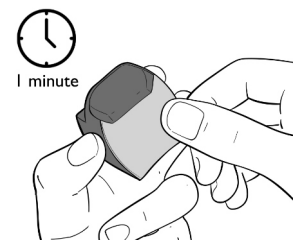
2. Thoroughly clean the adhesive surfaces on the bracket and helmet. We recommend the use of isopropanol or brake cleaner. The surfaces should be free of dust, grease and dry before applying the adhesive.

3. before cutting, consider how to cut the pad to ensure the best fit. Cut the adhesive pad according to the size of the contact area to achieve the best possible fit.



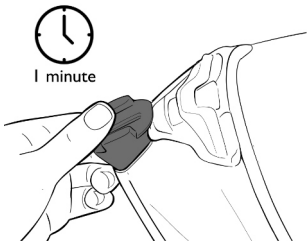
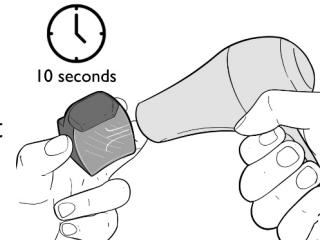
4. Remove the protective film from the VHB adhesive and heat it with a hairdryer or hot air gun for about 10 seconds until it is warm but not hot.

5. Stick the adhesive pad onto the contact surfaces of the holder. Hold the pad in place for about 1 minute.



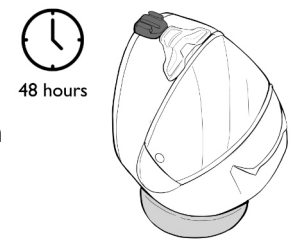
6. if bubbles appear during bonding, gently heat the area with a hairdryer or heat gun and apply pressure to the chin rest again. Repeat the process until the gap is gone.

7. After about 5 minutes, the process can be repeated on the other side and the holder can be attached to the helmet. First heat the adhesive pad for 10 seconds.



8. Now stick the holder onto the helmet and keep it there for 1 minute.

9 The adhesive should cure for a minimum of **48 hours**. However, we recommend that you allow the adhesive to cure for 72 hours and store it on a helmet pad with the chin facing upwards. If you do not have access to a hairdryer, we recommend extending the cure time by 24 hours.



Please check that everything is secure before the first time. The user is responsible for his equipment and the bond.
